March 2025 total Revenues: \$31,622.39; General Fund \$7964.44; Road Use Tax \$1,811.82; Local Option Sales Tax (LOST) \$4,135.21; Water \$8,115.49; Sewer \$6,981.75; and Storm \$2,613.68.

Sapp read a letter of resignation from Mayor Rick Terrones.

Motion was made by Burtnett, seconded by Adams, to approve Resolution #36 accepting Resignation, and approving the clerk to post notice of intent to fill Mayor vacancy by appointment. All Ayes.

Motion was made by Burtnett, seconded by Salasek, to approve Resolution #37 Approval of New Bank Signers. All Ayes.

Motion was made by Burtnett, seconded by Salasek, to approve Resolution #38 Accepting Contract for Park Pavillion. All Ayes.

Council discussed possible storm season clean up, by doing this on a case by case basis per council vote.

Council discussed clean up days for the community would be May 24; and Aug 16; 8am-2pm for this, and each of them will take a shift in order to monitor items going into the dumpsters and collecting appropriate fees from residents as necessary.
