Snow Ordinance in Effect

WINTER IS COMING-

Snow ordinances are in effect.

(November1-April 1)
Section 69.10 states:
No person shall park,
abandon or leave
unattended any
vehicle on a public street,
alley, or City-owned
off-street
parking area during the
snow removal
operations
unless the snow has been
removed or plowed from
said street, alley or parking
area and the snow has

ceased to fall.

Winter Season Regulations

Sidewalks: It is the responsibility of the abutting property owner to remove snow, ice and accumulations promptly from sidewalks. If a property owner does not remove snow, ice or accumulations within a reasonable time, the City may do so and assess the costs against the property owner for collection in the same manner as a property tax.

Snowmobiles: Snowmobiles may be operated upon streets which have not been plowed during the snow season for the sole and exclusive purpose of using the most direct roadway for the ingress to and egress from the City. No snowmobile shall be driven on any roadway solely for entertainment or pleasure. Snowmobiles shall not be operated in any park, playground or upon any other City-owned property without the express permission of the City. A Snowmobile shall not be operated on any City land without a snow cover of at least one-tenth of one inch.

Dumping of Snow: It is unlawful for any person to throw, push, or place or cause to be thrown, pushed or placed, any ice or snow from private property, sidewalks, or driveways onto the traveled way of a street or alley so as to obstruct gutters, or impede the passage of vehicles upon the street or alley or to create a hazardous condition therein; except where, in the cleaning of large commercial drives in the business district it is absolutely necessary to move the snow onto the street or alley temporarily, such accumulation shall be removed promptly by the property owner or agent. Arrangements for the prompt removal of such accumulations shall be made prior to moving the snow.

Snow Removal: A peace officer is authorized to remove, or cause to be removed, a vehicle from a street or highway, alley, parking lot to the nearest garage or other place of safety when any vehicle is left parking in violation of a ban on parking during snow removal operations.

Also, please help keep snow removed from around fire hydrants.

Roll Call: Present: Kelly Netcott, Tim Salasek, Ryan Severson, and Sean Ringgenberg (arrived at 7:15pm). Absent: David Hauge. Also present: Jennifer Davies – City Clerk; Gary Milam and Brandt Murry – public works.

Motion by Severson, seconded by Netcott, to approve the consent agenda as presented. Items approved include the agenda for December 13, 2022 meeting, minutes from November 9, 2022 meetings, and claims listed below totaling \$62,256.86. Sheriff's Office reported that there is a significant increase of thefts and break-ins this year. Everyone should keep an eye out for suspicious activity and do not hesitate to call 911.

Representatives from Allied Systems, Vision Electric, and Alliant Energy were all present to discuss the sewer building upgrades and installation of the generator. A variance request has been submitted to Alliant for the electrical work; and the gas line is to be installed within the next week. (Ringgenberg arrived at 7:15pm during this update).

A request was made to put the City Flag on the pole in front of City Hall. Everyone agreed.

Motion was made by Netcott, seconded by Ringgenberg, to approve Resolution #6: Approval of Contract with Slater Public Library for FY 2024. Roll call vote: Ayes: Netcott, Ringgenberg, Salasek, and Severson. Nays: none.

Mayor Kling opened the public hearing for Budget Amendment #1 for FY2023 at 7:38pm. Davies reviewed that this amendment is to be able to make payment to Westory Fire for the sale of Fire Truck; and to budget sewer building/generator update to FY 2023, as it was originally budgeted in FY 2022. She also reported no written or verbal questions or comments have been received regarding the recommended budget amendment. Having no questions or comments from those present, and no further discussion by Council, Kling closed the public hearing at 7:48pm. Motion was made by Ringgenberg, seconded by Netcott, to approve Resolution #7: Approval of Budget Amendment #1 for FY2023. Roll call vote: Ayes: Ringgenberg, Netcott, Salasek, and Severson. Nays: none

Motion was made by Ringgenberg, seconded by Severson, to approve Resolution #8: Approval of Transfer of funds from General fund to Sewer. Roll call vote: Ayes: Ringgenberg, Severson, Netcott, and Salasek. Nays: none.

Motion was made by Netcott, seconded by Severson, to approve Resolution #9: Approval of FY 2022 Street Finance Report. Roll call vote: Ayes: Netcott, Severson, Salasek, and Ringgenberg. Nays: none

Council reviewed and discussed the FY 2022 Annual Finance Report.

Motion was made by Severson, seconded by Salasek, to approve Resolution #10: Appointing Kenny Kling and Ryan Severson as Representatives to Story County Emergency Management Commission. Roll call vote: Ayes: Severson, Salasek, Ringgenberg, and Netcott. Nays: none Davies reported that state auditor is becoming more and more strict on items they consider "donations." This may have an affect on the City's ability to participate in Ballard Dollars for Scholars without being reprimanded by the State Auditor. Council feels this is a worthy expense, but must consider the consequences in continuing.

Council revisited /discussed the sewer upgrade / generator project. Motion was made by Salasek, seconded by Netcott, that we only pay 90% of the invoice until the electrical work has Alliant Energy approval, the generator is functioning, all aspects of the project are complete, and training of Kelley City Staff is complete. Roll Call vote: Ayes: Salasek, Netcott, Ringgenberg, Severson. Nays: none

Kling reported the County Emergency Management meeting is tomorrow (Dec 14th); the Fire pancake breakfast was a success, serving over 231 people. Westory Fire would like to THANK everyone for their support.

Milam reported on estimates he received for 1) concrete at the Sewer building, 2) lining of Sewer pipes to help reduce infiltration, and 3) cost of replacing some fire hydrants and installing shut off valves.

Motion was made by Ringgenberg, seconded by Salasek, to adjourn the meeting at 8:29pm.
